

### Priorities for the 2009 Legislative Session March 3 – May 1, 2009

#### I. MITIGATE OPERATING BUDGET CUTS

Since the General Revenue Estimating Conference held in mid-March, there has been continued tightening of credit market conditions, escalating energy prices, falling employment and further deterioration in the housing market as the nation faces an economic contraction. In response, the Revenue Estimating Conference has reduced its estimate of General Revenue collections for Fiscal Year 2008-09 by \$1.8 billion or 7.0% below the estimate from March. For Fiscal Year 2009-10, expected revenues were reduced by \$2.2 billion or about 8.0% from the earlier forecast.

With the downward revision in general revenue and lottery revenue estimates and the continued shortage of general revenue collections, the state will not release the full 25 percent of appropriated funds normally provided each quarter beginning July 1, 2008. According to the Executive Office of the Governor (EOG), only 24 percent will be released each quarter as they continue to monitor the economy and revenue collections. If this continued for the full fiscal year, the State University System would receive a four percent or \$96 million reduction in the operating budget (\$8M less for FIU). This would be in addition to \$165 million in cuts taken over the last nine months.

The Board of Governors is recommending a consolidated system enhancement request that reflects BOG's current strategic initiatives.

#### **TUITION FLEXIBILITY**

To offset anticipated budget cuts the universities will be seeking maximum flexibility to increase tuition revenue.

#### II. FIU MEDICAL SCHOOL

On March 23, 2006, the Board of Governors approved the implementation of a new medical school at FIU. The Legislature followed suit during the 2006 Session by authorizing the Board approved College of Medicine at FIU with the passage of HB 1237.

Within the BOG's SUS Medical Education Initiative for 2009-2010, \$10.9 million is requested specifically for Year 3 to implement the FIU Medical School. Fiscal year 2009-2010 will be the inaugural year for 40 students. FIU urges the Legislature to fully support the funding request as approved by the BOG in accordance with the LCME accreditation plan.

#### III. FIXED CAPITAL OUTLAY PRIORITIES

The Board of Governors has requested \$308 million from the Public Education Capital Outlay (PECO) Trust Fund for university projects. Of that, \$28.5 million is allocated to FIU for the following projects: \$7 million for Utilities/Infrastructure/Capital Renewal/Roofs, and \$21.5 million for the Student Academic Support Center.

FIU is seeking legislative approval for these projects, and will seek funding for additional capital priorities should funds become available.

#### IV. MAJOR GIFTS MATCHING PROGRAM

FIU asks the Legislature to support the Board of Governors request of \$102 million to fund the matching gifts program. The Matching Gifts program is a powerful incentive that FIU has been able to use to encourage large donations which enhance the universities' ability to attract recognized scholars, provide scholarships, and enable the improvement of our libraries. The Challenge and Courtelis Grant programs will help leverage potential donors to raise funds for existing university programs and is particularly important for the success of our medical school.

#### V. FACULTY AND STAFF SALARIES

Recognizing the limited availability of state funds, FIU supports policies and funding that will ensure FIU's faculty and staff are compensated appropriately.

FIU competes nationally to attract quality faculty to our campus. The University must face regional competition to retain qualified staff. Faculty and staff salaries continue to be one of the highest priorities for the BOG. The BOG and the state's universities have pledged to work together with the Florida Legislature to provide the funds that will allow FIU and the other state universities to compensate their faculty and staff on a competitive basis. The 2007 Legislature included university faculty and staff in the state pay package, but provided only a one-time \$1,000 bonus. FIU urges the Legislature to not let our faculty/staff miss a pay raise three years in a row.

#### VI. FUNDS TO SUPPORT STATE UNIVERSITY PRIORITIES

Rather than identifying individual university priorities by line-item, the BOG budget request was consolidated to reflect system goals. Such goals include:

- 1. Retaining faculty and staff \$8.6 million
- 2. Student Safety and Emergency Preparedness \$14.5 million
- 3. Florida Initiative for Global Education \$1.2 million
- 4. Facilities/Utilities and Operating Base Adjustment \$37.8 million
- 5. FL Center for Library Automation \$5.9 million

FIU supports these system priorities while recognizing projected revenue shortfalls may preclude their funding.

As we reflect on FIU's accomplishments at the federal level for the past year, <u>plans are already underway to develop Fiscal Year 2010 priorities</u>. Informal discussions have begun, and our goal is to have an agenda finalized by year's end.

While Congress has not determined whether it will return for a Lame Duck session, we wanted to share with you the highlights of this past year.

#### Earmarks: Potential Final of more than \$4 million

Despite 23 percent fewer FY '09 earmarks than 2005 (highest year), the cut is less than the 50 percent House leadership reduction goal. FIU did well compared to other Florida universities. With Congressional support, FIU potentially will receive more than \$4 million for hurricane research, the College of Medicine, and the College of Engineering and Computing, as follows:

- **1. \$3.2 million** (final) in Defense appropriation earmarks, the third highest of the 11 Florida SUS universities (as per project priorities submitted to SUS DC office). Specifically:
  - **a.** \$1.6 million (Rep. Ileana Ros-Lehtinen) for Mass Scale Biosensor Threat Diagnostics research
  - **b.**\$1.6 million (Rep. Alcee L. Hastings and Sen. Bill Nelson) for Western Hemisphere Security Analysis Center
- 2. \$750,000 in earmarks -- part of Continuing Resolution, not finalized, as follows:
  - **a**.\$.5 million (Rep. Lincoln Diaz-Balart) for storm surge research
  - b.\$.25 million (Rep. Lincoln Diaz-Balart) for a Mass Scale Biosensor Threat Diagnostics facility
- 3. \$TBD -- FIU share of \$2.4 million (final) multi-university DOD earmark

#### **Grants Support: \$4 million**

A major Federal Relations emphasis is providing needed federal relations grant support. This year's efforts helped lead to:

- \$4 million for DOE-EM and other related program work
- New MOU with DOD/Army for forensic work (future funding anticipated)

Additionally, we increased our emphasis for congressional grant proposal support, pro-active grant seeking, and Agency relationship building, including:

- Supported \$1.4 million Future House grant (proposal pending)
- Sought \$11.3 million FY '08 program funding for the National Windstorm Act implementation
- Cultivated relationships between Federal Relations/PI and DOD (Army and Navy), NIH, DHS, Dept. of Energy, Dept. of Education, Dept. of State, NSF, Dept. of Commerce, NOAA, and Miami-Dade County officials
- Partnered with Nova Southeastern University, to seek funding for hurricane mitigation in energy legislation/OCS oil drilling

#### **Legislative Priorities:**

Our principal focus was to give support for legislation providing FIU with program funding opportunities and to defeat/modify provisions that impose undue burdens on the university. Successes included:

- Enactment of the Higher Education Opportunities Act (first reauthorization of HEA in 10 years):
  - 1. Established new graduate education program for Hispanic Serving Institutions in Title V (with HACU)
  - 2. Increased significantly Pell Grant and other student financial aid funding
  - 3. Included Urban-Serving Research Universities Program in the House version (with USU coalition)
  - 4. Improved language that would have significantly penalized universities that raised tuition based on percentage of amount raised (with NASULGC and FL SUS)
- House passage of the DREAM Act (with NASULGC)
- House passage of the Paul Simon Study Abroad Act (with NASULGC)
- Introduction in House/Senate and Committee consideration of national windstorm reauthorization legislation; pledge for markup early in the 111<sup>th</sup> Congress; 3 of the 4 principal House sponsors; and FIU statement for the Committee's record.
- Introduction of comprehensive hurricane mitigation legislation by Senators Nelson and Martinez and Reps. Hastings and Ros-Lehtinen; FIU testimony
- Increased amount of funding for NIH, DHS, NSF, and Department of Energy Office of Science (assisted NASULGC and AAMC efforts).

#### **Advocacy in Washington and Campus Visits:**

This year marked a milestone in terms of the numbers and breadth of our federal advocacy efforts, as follows:

- Increased FIU representation coming to DC to advocate priorities
- Orchestrated lobbying trips to Washington for SGA leaders from both UP and BB campuses.
- Participated in Fly-Ins: Greater Miami CoC; HACU, AAMC, USU, NASULGC, and public health associations
- Leveraged association membership through governmental relations committees, leadership and participation
- Arranged campus visits by Reps. Ileana Ros-Lehtinen, Kendrick B. Meek, Lincoln Diaz-Balart, and Mario Diaz-Balart.

#### **New and Continued Initiatives:**

- Direct FIU's compliance with new lobbying disclosure and gift rules legislation
- Host Honors College's annual trip to Washington/Congress and FIU's DC Alumni meetings
- Publish Bi-weekly Federal Relations newsletter
- Run the FIU Washington Intern program, now in its 6<sup>th</sup> year, 18<sup>th</sup> intern

With respect to our funding requests, only the Department of Defense appropriation has been finalized; all other requests are covered by a Continuing Resolution that will fund the subject agencies at FY' 08 levels. FIU has two earmarks; two more are pending. It is expected that FIU will receive some TBD amount as part of its share of a multi-university earmark.

#### NEW FIU Logo Brief

#### Introduction

FIU's graphic identity is an important element in the branding and marketing of the University. All University communications should bear the institutional logo-the visual representation of our institution to our external community.

In May of 2008 a decision was made by executive leadership to revise the existing FIU logo and address the growing inconsistency in representation of our university across all its units.

#### **Situation Analysis**

There were several "official" FIU logos, including an "academic" logo with type and the FIU seal, and several "athletic" logos that feature our Golden Panther mascot.









#### **Timeline of Action**

*June 5, 2008* – Initial introduction email to faculty & staff, explaining process and logos under consideration.

*August 4, 2008*– Email to community solidifying the new logo choice and highlighting the style guide.

*September 1, 2008* – Logos.fiu.edu goes live, including a detailed guide and downloadable files for the FIU community.

Creating a recognizable and consistent logo generates a message of pride and community to both our internal and external audiences.





The logo has been designed to reflect both FIU's proud heritage and our confidence in the future. Building on our blue and gold tradition, the logo places a greater emphasis on the acronym "FIU", reflecting the way the university is referred to by all our constituents as well as the national media, during inter-collegiate athletic events. The FIU seal will be reserved for limited use on such official

items as diplomas and legal contracts (with few exceptions made for certain letterhead applications).

Our full name is prominent, ensuring the word international is present in even the smallest iterations of the logo. This is consistent with our strategic imperative, promoting a culture of awareness for our university's diversity and supporting the eventual redefining or the international to include educational opportunities.

Our new logo is not simply a redesign rather it is a consolidation effort. With its many disparate visual symbols FIU's image had become confusing and unfocused and our resources squandered by inconsistency. We realize that there will be precious little funding in the coming years for promoting FIU to our diverse constituents and this effort maximizes our impact and branding without necessarily increasing our resource commitment.



There were more than 40 additional images in use by FIU centers, institutes, museums, and departments. Because many of our colleges and schools have achieved renown in their own right, a variation of the selected logo will feature the name of individual colleges, schools, museums, and centers.

#### **Implementation**


In the interest of being cost effective, all creative development of this project was in-house. The implementation process we advocate is a fiscally responsible one as well. The prudent way to integrate these new images into our culture is to do so in the natural course of inventory depletion.

In the case of print materials, new orders or reorders should include the new logo. As the normal wear and tear of signage, emblems, banners and other collateral warrants, the replacements should include the new logo. We discourage anyone from purchasing unnecessarily in order to display the new logo while you have existing supplies.

SHORT BIOGRAPHIES

Proposed Guest Speakers

<u>Francis Fukuyama</u> <u>1<sup>st</sup> Morning Plenary</u>

Francis Fukuyama is Bernard L. Schwartz Professor of International Political Economy at the Paul H. Nitze School of Advanced International Studies (SAIS) of Johns Hopkins University, and the director of SAIS' International Development program. He is also chairman of the editorial board of a new magazine, The American Interest. Dr. Fukuyama has written widely on issues relating to questions concerning political and economic development. His book, The End of History and the Last Man, was published by Free Press in 1992 and has appeared in over twenty foreign editions. It made the bestseller lists in the United States, France, Japan, and Chile, and has been awarded the Los Angeles Times' Book Critics Award in the Current Interest category, as well as the Premio Capri for the Italian edition. He is also the author of Trust: The Social Virtues and the Creation of Prosperity (1995), The Great Disruption: Human Nature and the Reconstitution of Social Order (1999), Our Posthuman Future: Consequences of the Biotechnology Revolution (2002, and State-Building: Governance and World Order in the 21st Century, (2004), and America at the Crossroads: Democracy, Power, and the Neoconservative Legacy (2006). Francis Fukuyama was born on October 27, 1952, in Chicago. He received his B.A. from Cornell University in classics, and his Ph.D. from Harvard in Political Science. He was a member of the Political Science Department of the RAND Corporation from 1979-1980, then again from 1983-89, and from 1995-96. In 1981-82 and in 1989 he was a member of the Policy Planning Staff of the US Department of State, the first time as a regular member specializing in Middle East affairs, and then as Deputy Director for European political-military affairs. In 1981-82 he was also a member of the US delegation to the Egyptian-Israeli talks on Palestinian autonomy. From 1996-2000 he was Omer L. and Nancy Hirst Professor of Public Policy at the School of Public Policy at George Mason University. Dr. Fukuyama was a member of the President's Council on Bioethics from 2001-2005. He holds an honorary doctorate from Connecticut College, Doane College, and Doshisha University (Japan). He is a member of the Board of Trustees of the Rand Corporation, of the Board of Governors of the Pardee Rand Graduate School, and of the advisory boards for the National Endowment for Democracy (NED), the Journal of Democracy, the Inter-American Dialogue, The New America Foundation, and FINCA. As an NED board member, he is responsible for oversight of the Endowment's Middle East programs. He is married to Laura Holmgren and has three children.

Robert Kagan 2<sup>nd</sup> Morning Plenary

Robert Kagan is senior associate at the Carnegie Endowment for International Peace. His most recent book is *The Return of History and the End of Dreams* (Knopf 2008). His previous book, *Dangerous Nation: America's Place in the World from its Earliest Days to the Dawn of the 20th Century*, (Knopf 2006) was the winner of the 2008 Lepgold Prize and a 2007 Finalist for the Lionel Gelber Prize. His acclaimed book *Of Paradise and Power* (Knopf, 2003), was on *the New York Times* bestseller list for ten weeks and *the Washington Post* bestseller list for fourteen weeks. It was also a bestseller in the United Kingdom, France, Germany, Spain, Italy, the Netherlands, and Canada and has been translated into more than 25 languages. Dr. Kagan writes a monthly column on world affairs for the *Washington Post*, and is a contributing editor at both the *Weekly Standard* and the *New Republic*. He is listed as one of the world's "Top 100 Public Intellectuals" by *Foreign Policy* and *Prospect* magazines. He served in the State Department from 1984 to 1988 as a member of the Policy Planning Staff, as principal speechwriter for Secretary of State George P. Shultz, and as deputy for policy in the Bureau of Inter-American Affairs. He is a graduate of Yale University and Harvard University's Kennedy School of Government and holds a Ph.D. in American History from American University.

He is also author of *A Twilight Struggle: American Power and Nicaragua, 1977-1990* (Free Press, 1996), and is co-editor with William Kristol of *Present Dangers: Crisis and Opportunity in American Foreign Policy* (Encounter Books, June 2000.) He was born in Athens, Greece, in 1958.

#### Parag Khanna 1st Afternoon Plenary

Parag Khanna is Director of the Global Governance Initiative and Senior Research Fellow at the New America Foundation, one of the nation's most respected think tanks. He is author of *The Second World: Empires and Influence in the New Global Order* (Random House, 2008). This ground-breaking book has been hailed by Robert Kaplan as "a savvy, streetwise primer on dozens of individual countries that adds up to a coherent theory of global politics." *The Second World* is a compelling look at the current geopolitical marketplace, exploring America's slip from dominance, the rise of the European Union and China as rival models for global leadership, and the emergence of the strategic 'second world' markets and how they adapt to and shape globalization. With razor-sharp analysis, Khanna provides a road map for the U.S. to renew our competitiveness and avoid slipping into second world status.

During 2007 Khanna served as a senior geopolitical advisor to United States Special Operations Forces in Iraq and Afghanistan. Prior to joining New America he was the Global Governance Fellow at the Brookings Institution, and worked for several years at the World Economic Forum in Geneva, specializing in risk analysis, multi-stakeholder partnerships, and shaping the annual Davos agenda. He has also been a researcher at the Council on Foreign Relations in New York, conducting projects on terrorism, conflict resolution in Central Asia, U.S. policy towards South Asia and defense policy.

Khanna's essays and reviews have appeared in *The New York Times, Washington Post, Financial Times, Harper's, The Guardian, Policy Review, The National Interest, Foreign Policy, Los Angeles Times, Prospect, Slate.com, The New Republic, Survival, The New Statesman, Washington Times, Daily Star (Lebanon), Indian Express, and India Today.* He has been featured on CNN, BBC, Al Jazeera International, National Public Radio (NPR), MTV World and other media. His travel writing has covered countries including Russia, Lebanon, Cambodia, Turkey, and Pakistan. He has coined or pioneered such terms as Geodiplomacy, Bollystan, Second World, and Multi-Americanism.

He holds a Bachelor of Science in International Affairs and a minor in Philosophy from the School of Foreign Service at Georgetown University, a Masters Degree from Georgetown's Security Studies Program, and is earning a PhD in International Relations at the London School of Economics.

He was awarded the OECD Future Leaders Prize and is a member of the Explorers Club.

He speaks German, Hindi, French, Spanish, and basic Arabic.

### <u>Fareed Zakaria</u> <u>2<sup>nd</sup> Afternoon Plenary</u>

**Fareed Zakaria** was named editor of Newsweek International in October 2000, overseeing all Newsweek's editions abroad. The magazine reaches an audience of 24 million worldwide. He also writes a regular column for Newsweek, which also appears in Newsweek International and fortnightly in The Washington Post. Starting this year, he will host a new foreign affairs show on CNN Worldwide.

Zakaria was the managing editor of Foreign Affairs, the widely-circulated journal of international politics and economics. He is the author of several books, including "The Future of Freedom," which was a New York Times bestseller and has been translated into 20 languages. His new book, "The Post American World," is being published in May 2008.

Zakaria has won several awards for his columns and cover-essays, in particular for his October 2001 Newsweek cover story, "Why They Hate Us." In 1999, he was named "one of the 21 most important people of the 21st Century" by Esquire Magazine. In 2007, he was named one of the 100 leading public intellectuals in the world by Foreign Policy and Prospect Magazines. He has received honorary degrees from many universities. He serves on the board of Yale University, The Council on Foreign Relations, The Trilateral Commission, and Shakespeare and Company.

He received a B.A. from Yale and a Ph.D. in political science from Harvard. He lives in New York City with his wife, son and two daughters.
